**Sale of Water from Lake O the Pines to North Dallas Area:** Laura-Ashley of the Caddo Lake Institute updated the board on the potential sale of water and science around flows downstream. No guardrails are yet worked out. Engagement in the process as people affected is appropriate. Half of the water rights belong to Northeast Texas Municipal Water District the other half belongs to seven cities. (Avinger, Daingerfield, Hughes Springs, Jefferson, Lone Star, Ore City, and Pittsburg).

**Request for funds:** Vice President Angela Anderson read President Steve Woodson's proposed amendments to the Bylaws as follows:
