**(Revised) Minutes of Meeting of the Board of Directors**

**March 12, 2025**

**Treasure's Report:** The Treasurer's Report was reviewed. It was approved after a motion by Sandra and seconded by John.

We have \$31,551.81 in CDs. Judy motioned to approve the closure of the 3 current Certificates of Deposits and put them into one 8-month CD with a much higher interest rate, as well as for the board to review the proposed renewal rate prior to auto-renewal for competitive rate comparisons. Angela seconded; motion carried. There will be a penalty, but it will be offset by the increase in interest income. The Treasurer and the President will be signers on the checking account and other financial documents. This should be stated in the By-laws.
